Operations Report and Updates (B. Chernish)

9.1 Current Project Updates

The entrance lighting pole replacement is being evaluated and quotes are being obtained. One quote has been received to date from Cornell Feenstra Electric. The Facility Operator will return with a report once all quotes are received.

The new T-Hanger engineering and costing is still in progress and should be received by end of week.

The stone for Commercial Drive is being laid and nearly complete, there is more leveling that is needed.

The front gate signage will be ready to be erected next week.

Two more accessible parking spaces will be designated in the parking lot.

10. Financial/Office Update/Reports

The Bookkeeper relayed that there was a large fuel purchase and approximately \$14,000 in fuel sales for the month of May.

The loan for the Hanger project will be advanced from the City of Welland on June 1st, the Bookkeeper anticipates there will be high interest earned on the funds and the first loan payment will be due July 1st, 2023.

11.1 Regional Road #529 (River Road) – Road Condition (Commissioner Bruno) (Attachment)

Commissioner Bruno relayed concerns with the current road conditions along Regional Road #529. The road is in a state of disrepair and road maintenance along that roadway is the responsibility of Niagara Region. Commissioner Bruno proposed the following motion:

Whereas, the Niagara Central Dorothy Rungeling Airport is located at Regional Rd. 529 (435 River Road), Fenwick Ontario;

And Whereas, the section of Regional Rd. #529 (River Road) between O'Reilly's Bridge (Regional Road #627) and the end of the airport frontage, just past the airport entrance driveway has been in a serious state of disrepair for many years;

And Whereas, Regional Rd. #529 (River Road) maintenance and repair is the responsibility of the Niagara Region;

THEREFORE BE IT RESOLVED THAT, the Airport Commission request the Niagara Region make the necessary resurfacing to improve road conditions on Regional Rd. 529 (River Road) from O'Reilly's Bridge along the entire airport frontage on River road;

AND THAT a copy of this resolution be forwarded to the Niagara Region, Town of Pelham; City of Port Colborne; Township of Wainfleet and the City of Welland.
